This responds to your Freedom of Information Act (FOIA) request of August 9, 2008, in which you requested information that records the entry, exit, time, and place of Dr. Bruce E. Ivins on September 17, 18, October 6, 7, 8, and 9, 2001, at the United States Army Medical Research Institute of Infectious Diseases (USAMRIID), Fort Detrick, Maryland. You also requested any surveillance or security camera footage which depicts Dr. Ivins on these same dates. Your request was received on August 11, 2008.


Enclosed is the recorded information that identifies Dr. Ivins' entry, exit, time, and place, for the requested dates.

No surveillance or security camera system was in effect at USAMRIID on the dates of your request thus constituting a negative response for this portion of your request.

Because your request has been denied in part, you are advised of your right to appeal this determination to the Secretary of the Army. If you decide to appeal at this time, your appeal must be submitted within 60 days of the date of this letter. In your appeal, you must state the basis for your disagreement with the denial and the justification for the release of information associated with your request for this command. Your appeal should be addressed to: U.S. Army Medical Command, Attention: Freedom of Information/Privacy Acts Office (MCPA), 2050 Worth Road Suite 21, Fort Sam Houston, Texas 78234-6021, for forwarding, as appropriate, to the Office of the Secretary of the Army. Please enclose a copy of this letter along with your appeal. To ensure proper processing of your appeal, the letter and the envelope should both bear the notation, "Privacy Act/Freedom of Information Act Appeal."
